

Central Scotland Green Network 2010 Forestry Baseline Survey

This study presents a baseline evaluation of forestry and woodland related activities in the Central Scotland Green Network (CSGN). The evaluation focused retrospectively on 2010, the year in which the CSGN was launched. It quantified twelve forestry-related indicators covering a range of benefits to the local environment, society and economy. It is envisaged that the indicators and their baselines will be used by CSGN partners to provide a basis for monitoring changes and investigating the impact of new interventions carried out as a result of the partnership.



Background

The CSGN initiative was launched in 2010. It covers the entire area of 15 local authorities and parts of four other local authorities across the Central Belt of Scotland. It aims to provide a range of environmental, economic and social benefits by restoring and transforming the landscape of the area. The CSGN is of strategic importance to the Forestry Commission.

Objectives

A key goal of the present study is to supplement an existing baseline assessment of the CSGN with a more comprehensive suite of forest-related indicators, with a focus on economic values. The indicators will allow Forestry Commission Scotland (FCS) to monitor changes to the forestry sector and help them to evaluate the impacts of forest-related interventions.

Methods

Where possible existing data were utilised, in particular from Forestry Commission Scotland, the Scottish Government and the Office for National Statistics. In several cases, adjustments were needed to ensure indicator values only covered the CSGN area. A description of the methods used for the individual indicators are provided in the main report of this study.



Findings
