

Integrated Environmental and Economic Accounting for Forestry: UK 2013 data

Publication date: 8 October 2015

Introduction

The Integrated Environmental and Economic Accounting for Forestry (IEEAF) collects economic data on forestry. Statistics have been collected annually by Eurostat.

UK data that is submitted to Eurostat via the IEEAF has been published annually, in October at: www.forestry.gov.uk/forestry/infd-8ekk3r

The attached table shows data for 2004-2013. Estimates for 2013 are shown for the first time in this return. Estimates for 2012 and earlier years have been subject to revision since the release of 2012 data in October 2014, to reflect revisions to underlying data.

The IEEAF is being replaced by a new Forest Accounts (FA) questionnaire that is being piloted by Eurostat in Autumn/ Winter 2015. The UK IEEAF data for 2013 shown here will be used in reporting to Eurostat as part of the FA pilot.
