

Background

The scheme was undertaken by the Westcountry Rivers Trust as part of a Test and Trial project. It used a reverse auction based upon the NatureBid auction platform developed by a partnership involving the Environment Agency and the Sylva Foundation. Reverse auctions help reveal the actual cost of implementing a measure as farmers understand their business costs better than external bodies. Bidding in this way reveals the sellers that can provide the environmental outcome at the lowest cost. These costs, however, can be higher or lower than published standard costs depending on factors such as the measure and area in question, as well as the level of competition for funding.

Site description and management

The Tamar Trial included ponds, wetlands, and woodlands. These measures required post-auction negotiation and refining due to the nature of the measures. The auction focused on improving water quality in the area, and was funded through a blended finance approach. This involved a mix of public sector, private sector and NGO funding. The main funders included several local businesses and Defra. The local businesses included agricultural and food businesses, as well as a water company. One of the funders was solely interested in funding tree planting. A total of 8 measures were funded. These are shown on the next page.


