#### 7. TERMS AND CONDITIONS

I confirm that:

(a) An area of covered hardstanding has been designated within the premise for receiving Phytophthora affected woodchip and other co-product. All co-product, residue and plant debris shall be swept up from this area and kept segregated and disposed of as set out below, and;

( b ) an area of hardstanding has been designated within the premises for sweeping down vehicles after unloading, and all co-product, residue and plant debris shall be swept up from this area and kept segregated as disposed of as set out below, and;

( c ) that no vehicles delivering Phytophthora affected wood to the premises shall be allowed to leave the premises until they have been swept clean, and ;

(d) all Phytophthora affected woodchip and other co-product and plant debris derived from Phytophthora affected wood shall be **burnt on site as woodfuel.** Woodchip and other co-product and plant debris, shall only be permitted to move under the authority of a Movement Licence to other facilities so Licenced for the purpose by the Forestry Commission, and;

(e) I understand that the premises may be visited by an authorised Plant Health Inspector at any reasonable time for the purpose of ensuring that these conditions are being complied with. I understand that records of all deliveries Phytophthora affected wood and records of all consignments of plant debris and sawmill co-product and residue derived from Phytophthora affected wood shall be made available to the inspector on request.

(f) Woodchip and other co-product and plant debris stored under cover must NOT be in direct contact with live growing plants e.g. overhanging trees species or rhododendrons and heathland species susceptible to *Phytophthora ramorum* 

(g) Phytophthora affected wood materials shall only be permitted to move under a Movement Authorisation to other facilities so authorised for the purpose by the relevant authority and must not be exported outside of Great Britain. Subsequent movement of co-product, residue and plant debris derived from Phytophthora affected wood shall be in covered or enclosed transport

#### 20. DEFINITIONS:

For the purposes of this licence the following terms are defined:

"**Relevant authority**" shall mean the Forestry Commission for authorisations granted in England, Welsh Ministers for Wales and Scottish Minsters for Scotland.

"**Phytophthora affected wood**" shall mean any tree species originating in sites known to be infected with *Phytophthora ramorum* and from which the movement of wood has been restricted by a relevant authority.

"**Co-product, residue and plant debris**" shall be any material, organic or otherwise, that arises as a consequence of keeping, handling and processing the Phytophthora affected wood. It does not include the square sawn timber recovered, which has no restriction placed on its further movement.

" **Management Zone (Scotland)**" – details of the management zone can be viewed at https://forestry.gov.scot/sustainable-forestry/tree-health/tree-pests-and-diseases/phytophthoraramorum#:~:text=Management%20Zone%20(MZ),ramorum%20Management%20Zone)%20Ord er%202014. Processing and Movement licences are only required when Phytophthora ramorum affected larch wood, co-products, residues and plant debris are moved out of the Management (Scotland) Zone to FC licensed premises elsewhere in GB.
